

PRESIDENT'S MESSAGE





New York State Toughened the law against license plate covers? It bans the sale of any covering over a license plate and increased the penalties for using them. The fine has increased from \$100 to a maximum of \$500. Drivers with three or more convictions within a five-year period can face a 90-day suspension of their registration. NYS as also included the condition of the license plates on your yearly inspection certificate. You can replace pealing plates at no cost at your local DMV. Do so now before NYS starts rejecting inspections due to unreadable plates.

ICE (Internal Combustion Engine) / Vehicle Choice An update from last month: U.S. House Passed Resolution to Overturn EPA EV Mandates; Heads to U.S. Senate for Action. However, Action has been tabled on 9/23 for reconsideration, at a time to be determined by both the House and Senate. Further updates will be reported when available.

ZEV: SEMA and NTEA (The Work Truck Association) filed federal Lawsuit to Stop advanced Clean Fleets EV Truck mandates against the CARB (California Air Resources Board). They are seeking immediate declaration and injunctive relief to stop electric vehicle mandates CARB intends to implement through its Advanced Clean Fleets (ACF) regulations. AFC regulations include requirements that only ZEV may cross within California's borders. This action goes in the face of a state law passed by their legislature over 20 years ago that states CARB "shall not require ... a ban on the sale of any vehicle category in the state." among other legal standings. They further take the position that:

"Ultimately, work trucks must be available, capable and affordable. It is important to reach this desired outcome using a sensible and cost-effective approach so our member businesses can continue to build and supply the vehicles that are essential for commerce." Said NTEA President and CEO Steve Carey. "Left unchecked, the current suite of California regulations will severely curtail the ability of work truck users to obtain the vehicles they need to successfully and efficiently carry out their vital missions and support ongoing business operations."

Neither SEMA or NTEA are anti EV, but steadfast in their shared belief that a technology-neutral approach is the best way to achieve lower vehicle emissions.

Federal Government Expands Copyright Exemptions. Vehicle owners and businesses acting on their behalf have received a three-year exemption from federal copyright infringement laws when accessing, storing and sharing vehicle operational data, including diagnostic and telematics data, the Librarian of Congress (LOC)recently declared. This exemption preserves the vehicle owners right to

choose who he/she wants to work on their vehicle and parts used to repair said vehicle

The U.S. Department of Commerce's Bureau of Industry and Security is proposing a rule that would prohibit the sale or import of connected vehicles that include specific pieces of hardware and software, along with the sale of those components, with a sufficient nexus to the Peoples Republic of China or Russia. The specific are ones integrated into Vehicle Connectivity Systems (VCS) and software integrated into levels 3, 4 and 5 Automated Driving Systems (ADS), defining a "connected vehicle" as an on-road vehicle that "integrates onboard networked hardware with automotive software systems to communicate via dedicated short-range communication, cellular telecommunications connectivity with any other network or device."

The proposed policy would include the following Prohibited Activities and Penalties:

- Knowingly importing into the United States VCS hardware that is designed, developed, manufactured or supplied by persons linked to China or Russia
- Knowingly importing into or selling within the United States completed connected vehicles that incorporate covered software designed, developed, manufactured by persons linked to China or Russia.
- Knowingly selling in the United States connected vehicles that incorporate VCS hardware or covered software if the seller is linked to China or Russia, regardless of whether the vehicles are manufactured or assembled in USA.
- The rule prescribes civil penalties of up to \$286,136 per violation and criminal penalties, including fines of up to \$1 million and / or imprisonment for up to 20 years.



Fred and August Duesenberg

The Duesenberg name has become synonymous with some of the finest automobiles ever produced. Thanks to Gary Cooper and Clark Gable, who both owned Duesenberg Model SSJs, the Duesenberg name came to be associated with Hollywood Alisters. While the Duesenberg brothers excelled at innovations and quality, the business side lagged. The onset of the Great Depression didn't help either.

Friedrich Duesenberg was born in 1876; August was born in 1879. They were two of seven children born to Konrad and Luise Düsenberg in Lippe, currently in Nordrhein-Westfalen. After the father Konrad died in 1881, older brother Henry emigrated to Iowa in 1884. In 1885 their mother Luise sold the farm in Germany and brought the rest of the family to America. The oldest son Konrad bought a farm for the family in Iowa. Fred Duesenberg displayed mechanical aptitude already as a boy. He quit school after eighth grade; he gained most of the rest of his engineering and design abilities by experience. Fred and August started tinkering with bicycles and bicycle racing.

Eventually the two brothers started designing internal combustion engines for building motorcycles. The opened two bicycle repair shops in succession after 1900 that failed rather quickly, the second venture because August had taken a job elsewhere in 1903. Their separation did not last long, thanks to Edward Mason's offer to Fred for them to design and build automobiles in 1906. The Mason Motor Car Company reorganized after Fred Maytag had bought a controlling interest in the company in 1909 and renamed it the Maytag Mason Motor Company, Maytag, who also had German family roots, already enjoyed commercial success with his washing machine and appliance business.

The Duesenberg brothers started designing reliable and powerful two-cylinder and four-cylinder engine. They also understood that entering their Maytag Mason cars in races was a way to advertise them. The plan seemed not to work for long. Fred drove one of his cars into a fence.

By 1910, the Duesenberg partnership with Maytag-Mason was all but over. The Duesenberg brothers concentrated on engine design in their own shop. The partnership formally dissolved in 1912. The follow year they moved to St. Paul, MN. The same year they established the Duesenberg Motor Company. That company merged with Loew Victor Manufacturing to create Duesenberg Motor Corporation in 1917. They also moved to New York as U.S. involvement in World War I was becoming

inevitable. Their East Coast operations began producing marine engines and aircraft engines. During the war they learned a lot from Italian Ettore Bugatti's aircraft engine designs. That relationship inspired the brothers to design a powerful and reliable straight-eight-cylinder engine that eventually became their specialty.

In 1919 Duesenberg Motor Corporation sold out to John Willys, and the brothers moved to Indianapolis. There they formed yet another company, Duesenberg Automobile and Motors Corporation to concentrate on passenger cars. Fred now served as president and August served as assistant engineer. The Duesenberg Model A resulted in 1920. It boasted of significant firsts and cutting-edge technology: an inline eight-cylinder engine and four-wheel hydraulic brakes. It did not sell well. It was too expensive, and the public found the body design ugly. Duesenberg's finances went on a bumpy ride for the next several years and the company ended up in receivership.

E. L. Cord bought Duesenberg out in 1926 with big plans to produce world-class luxury cars. By this time, it was quite obvious that the Duesenberg brothers were far better at the technical aspects of the automobile business than the business aspects. Cord Kept them on. Still, the brothers did launch a side hustle – Duesenberg Brothers – designing and building race cars. This eventually became August's main occupation. In 1927 a very limited run (only 13) of Model X, a sporty upgrade of the Model A, rolled out. In 1928 Duesenberg, now a subsidiary of Cord, rolled out its Model J, which remained in production until 1937. This was always to be a limited-run luxury model, but it was impressive: top speed well over 100 mph, and with an engine second to none. Body appointments were to be custom manufactured for each order, usually by other companies specializing in auto bodies.

A supercharged version of the Model J introduced in 1932, the Model SJ, was capable of 140 mph, but new orders for Duesenberg dried up as the Depression bore down – except for a few orders from Hollywood stars. Production ended in 1937. By that time Fred was gone, having died in 1932. August and his nephew mainly concentrated on racing and tried to keep the Duesenberg legacy alive until August's death in 1955.

He picked up two hitchhikers, one was in the passenger seat and the other one was in the rumble seat.

He left Jennerstown, driving down the hill. The road was very curvy (some of the nine turns have since been straightened). Two cars were coming up the mountain and one was passing the other.


Fred encountered the passing car coming straight at him and he swerved sending the car into a clockwise spin, but it never left the road. Fred fell out of the car when the suicide door opened up; his two passengers were also injured. The rumble seat passenger was thrown from the car and just received road rash; the inside passenger was knocked unconscious. Fred was taken to the area hospital with a broken clavicle, broken ribs and possibly a bruised lung. He was discharged 3-4 days later. He developed Pneumonia from his injuries and on July 26, 1932, he died.

The car was not that badly damaged (flat tire & bent tie rod) and was towed by a Pierce Arrow tow truck to a nearby garage. The garage owner fixed the car, then he and his sons drove it around for several days.

The car was then purchased after the accident by Duesenberg. Duesenberg had trouble reselling the car as it was now known as the death car. Unknown where the car was until in 1972 when it was purchased by Bob Friggens and now sported a yellow paint job.

The road marker indicating where the accident happened was knocked over by a snow plow and then stolen. It was not totally accurate and a new one is being planned.
