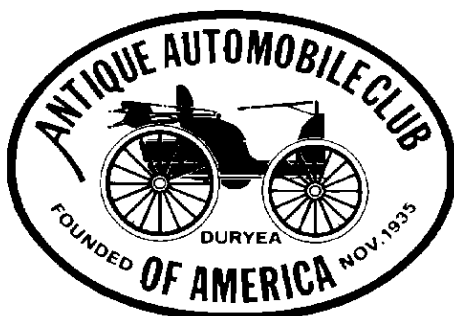

This is our second year at the Como Park Bowen Road Grove, and we hope all our members will participate in this year's show as well as encourage other car owners to do the same. There are many opportunities to participate in the show in addition to judging, including parking cars, directing traffic, registration, providing directions, and of course, clean-up. The following is information about our **Class 1** cars that might interest you.

Class 1A is for cars that have received the prestigious achievement of a National First Junior, Senior or Grand National Award. These cars have been point judged based on authenticity and condition in national competitive classes.

Class 1B is for cars that have been recognized as Historic Preservation of Original Features, otherwise known as HPOF. Cars receiving this award are focused on the preservation of the vehicle is it's original as-manufactured condition, retaining significant feature in original condition.

Class 1C is the National Driver's Class award. Cars in this class must be certified upon passing a visual inspection and must provide evidence of being factory assembled.

Class 1D is new this year. This class is reserved for Classics that have historical significance, unique design, and cultural impact. The Classic Car Club of America has specifics on what vehicles fit this category, and have this information listed on their website at www.classiccarclub.org.

We hope to see you at the show, and even better, as a volunteer!

Legislative Affairs Info

ZEV (Zero Emission Vehicle) / ICE (Internal Combustion Engine) / Vehicle Choice

EPA Announces Plan to reverse Federal EV Mandates: EPA will reconsider the federal motor-vehicle emission standards that require automakers and truck manufacturers to increase zero-emission vehicle sales (known as the Model-Year 2027 and Later Light-Duty and Medium-Duty Vehicles regulation and Greenhouse Gas Emissions Standards for Heavy-Duty Vehicles). Today, only EV's and five plug-in hybrid vehicles meet these standards. The EPA will reconsider its March 2024 vehicle emission regulations for model-years '27-'32, which states 2 out of every 3 new vehicles sold to be EV's by 2032. The EPA will also re-evaluate the 2022 Heavy-Duty Nitrous de (Nox) rule, a centerpiece of the Biden Administration's Clean Truck Plan. California's EV mandate and ICE ban-known as ACCII and currently impacting 11 other states-remains in place and is not affected by these EPA actions. Congress has until mid-April to overturn the federal waiver that enables the California mandates (see my report in last month's newsletter).

Tariff Update: Trump unveiled his plan for tariffs on the automotive industry on March 26th, impacting cars, trucks and SUV's along with various parts and components. According to the White House, a 25% tariff will be levied on imported automobile on April 3rd and a later date for automotive parts (no later than May 3rd). The Higher-Level Details:

1. A 25% tariff will be applied on complete, imported passenger vehicles and light trucks.
2. Key auto parts – engines, transmissions, powertrain parts and electrical parts are subject to the tariffs.
3. Importers of Autos under the U.S. -Mexico-Canada Agreement (USMCA) will be given the opportunity to certify their United States content, and the 25% tariff will only apply to the value of non-U.S. content.

4. Auto parts that are USMCA-compliant will remain free until the U.S. Secretary of Commerce, in consultation with the U.S. Customs and Board Protection (CBP), establishes a process to apply tariffs to their non-United States content.

SEMA and PRI's (Performance Racing Industry)

Update: Arkansas House Bill (HB) 1564 covering rural race track in Arkansas, which proposed new insurance requirements, limitations on noise levels, hours of operation and types of events that venues can hold. SEMA & PRI mobilized quickly along with local support (7000 letters and 400,000 views of an Instagram reel promoting the letter writing campaign) were successful in having HB1564 officially withdrawn. This is a definite success to protect Grassroots Racing in Arkansas.

Updates: NY S00261 – Prohibits idling of any passenger vehicle for more than 3 minutes. Status, still in the Senate Environmental Conservation Committee. (3/4/25)
 NY A00075 – Require repair shops to disclose type of parts used in collision repairs. Status, still in the Assembly Transportation Committee. (3/4/25)

NY S00344 – Provides that a person may operate a fully autonomous vehicle on public roads in NYS. Status, still in the Senate Transportation Committee. (3/4/25)

Classic / Antique Car Beat: Jay Leno, a lifelong collector and advocate for the automotive culture, is backing California State Bill 712 introduced by Senator Shannon Grove which has been affectionately being called "Jay Leno's Law". The bill if passed, would exempt vehicles 35 years or older from smog checks if they are insured as collector cars. "From car shows to weekend cruises, classic cars bring people together and keep history vibrant," added Senator Grove.

- Cars 1925 & Older – FREE Registration.
- Gate opens at 9:00 am.
- All Vehicles must be insured with proof.
- UL approved & fully charged Fire Extinguisher is required in all cars to be judged.
- "For Sale" signs are prohibited on Judging Field. These are allowed in the Display Only class only.
- All vehicles must be driven through registration and on to the Show Field under their own power.
- Convertible tops and windows must be up for judging. Car doors should be unlocked so judges can view interiors. Hoods and trunks should be open during judging.
- All cars will be judged based on condition / restoration to the same state as the dealer could have prepared the car for delivery to the customer. This includes any feature, option or accessory shown in the original factory catalog, parts book, sales literature, or company directives for the model year of the vehicle. Point deductions will be made for each component that is incorrect, e.g. each radial tire found on a vehicle that was not originally delivered from the dealer with radials will be counted as a point deduction.
- Modifications or changes may result in point deduction except for Modified Classes.
- The Chief Judges have final decisions on all judging matters.
- AACA LER will not be responsible for damage to vehicles on show field.
- Owner should remain with vehicle during judging.
- Cars must be on the show field by **NOON** & should remain until trophies are awarded. Entrance gate will close at **NOON**.

All cars will be judged based on condition / restoration to the same state as the dealer could have prepared the car for delivery to the customer. This includes any feature, option or accessory shown in the original factory catalog, parts book, or sales literature for the model year of the vehicle. Point deductions will be made for each component that is incorrect, e.g. each radial tire found on a vehicle that was not originally delivered from the dealer with radials will be counted as a point deduction.

- The Chief Judge has final decisions on all judging matters.

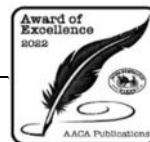

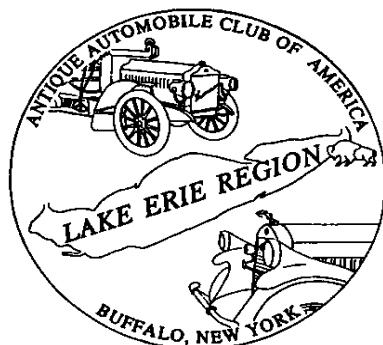
