

Legislative Affairs Info

ZEV (Zero Emission Vehicle) / ICE (Internal **Combustion Engine) / Vehicle Choice**

House Does Its Job; SEMA Looks to Senate for Final Action on Calif. EV Mandates, ICE Ban: The US House of Representatives in a bipartisan vote of 246 -164 to overturn California's Clean Air Act waiver for the states Advanced Clean Cars II (ACCII) policy (a.k.a. EV mandates or ICE vehicle bans. It's now on to the Senate Republicans and Democrats to stand up and declare that California does not speak for our nation, that the Golden States policies are not solutions for our countries issues, and that it is not partisan to say, "I believe in America Ingenuity, not mandates."

"Ban the Ban" Rolls Forward in West Virginia: The West Virginia Legislature passed legislation prohibiting the state from restricting the use, purchase or sale of vehicles based on their energy source, i.e. electric-vehicle (EV) mandates that would ban internal combustion engines. The "ban the ban" bill is on the way to Governor Patrick Morrisey's desk, and he is expected to sign the bill into law.

Cracks Forming: Maryland Pauses Enforcement of California's EV Mandate: Indications are that states are growing weary of tethering themselves to California's oppressive emission standards. Maryland is making a significant change to its compliance with the Advanced Clean Cars II (ACC II) regulation.

Maryland Gov. Wes Morre issued an executive order last week delaying enforcement of the state's adoption of ACCII, which bans the sale of new gas-powered cars by 2035. Starting in the 2026 model year, 35% of new vehicle sales must be electric. Maryland is one of 11 states that have adopted ACCII, but the new order acknowledges that the state is not ready to fully implement the rule. The order pauses penalties for manufacturers that miss electric sales targets in 2027 and 2028 and establishes a working group to recommend ways to make the mandate more workable.

Tariff Update: Tariffs are a complex topic that can evoke strong emotions and concerns. Currently, if it hasn't changed today, the E.O. (Executive Order) exempts several categories of items, including:

Articles subject to 50 USC 1702(b) (IEEPA general exclusions for donations, goods in personal effects/baggage, information transfers, postal and other transactions that do not involve the transfer of anything of value);

Steel/aluminum articles and autos/auto parts already subject to Section 232 tariffs;

Copper, pharmaceutics, semiconductors and lumber articles;

Bullion; and Energy and other certain minerals not available in the United States.

I expect that tariffs will continue to be in flux for the next few months due to continuing negotiations.

SEMA and PRI's (Performance Racing Industry) **Update:** Iowa Legislature passed bill (HF 645 that provides immunity to racetracks from nuisance claims brought by surrounding property owners, so long as the track existed before the neighboring property was purchased or developed. This ensures these venues can continue to thrive without constant threat of litigation.

Oregon Bill was defeated with the help of SEMA and PRI: Oregon House Bill 2738, which aimed to ban the use of leaded fuel at Portland International Raceway (PRI), and thus shut down the race track. However, the bill missed a critical legislative deadline and will not advance this year.

Classic / Antique Car Beat Update: California Senate Committee approved California State Bill 712, commonly known as Leno's Law after Jay Leno, a lifelong collector and advocate for the automotive culture, backed California State Bill 712 introduced by Senator Shannon Grove. The bill will now move on to the Senate Appropriations Committee, where it will be considered in late April and if approved it would go for a vote in the State Senate. If enacted, the law would exempt vehicles 35 years or older from smog checks provided they are insured as collector cars. "From car shows to weekend cruises, classic cars bring people together and keep history vibrant," added Senator Grove.

- UL approved & fully charged Fire Extinguisher is required in all cars to be judged.
- "For Sale" signs are prohibited on Judging Field. These are allowed in the Display Only class only.
- All vehicles must be driven through registration and on to the Show Field under their own power.
- Convertible tops and windows must be up for judging. Car doors should be unlocked so judges can view interiors. Hoods and trunks should be open during judging.
- All cars will be judged based on condition / restoration to the same state as the dealer could have prepared the car for delivery to
 the customer. This includes any feature, option or accessory shown in the original factory catalog, parts book, sales literature, or
 company directives for the model year of the vehicle. Point deductions will be made for each component that is incorrect, e.g. each
 radial tire found on a vehicle that was not originally delivered from the dealer with radials will be counted as a point deduction.
- Modifications or changes may result in point deduction except for Modified Classes.
- · The Chief Judges have final decisions on all judging matters.
- AACA LER will not be responsible for damage to vehicles on show field.
- Owner should remain with vehicle during judging.
- Cars must be on the show field by NOON & should remain until trophies are awarded. Entrance gate will close at NOON.

All cars will be judged based on condition / restoration to the same state as the dealer could have prepared the car for delivery to the customer. This includes any feature, option or accessory shown in the original factory catalog, parts book, or sales literature for the model year of the vehicle. Point deductions will be made for each component that is incorrect, e.g. each radial tire found on a vehicle that was not originally delivered from the dealer with radials will be counted as a point deduction.




